Anyone may take the rug ID exam.\* Examinees will be expected to identify rugs as to age, origin, weave, and content.

**Once again, on Friday July 14, 2014 at Atlanta’s AmericasMart, ORRA will present its Certified Oriental Rug Appraiser’s Exam.** The test will consist of two parts; the first half is written and the second half is rug identification.
